a. Operator Report

Ms. Copen gave the School Report. Three students were Student of the Month for their respective classes. Each student received a certificate and their family received a gift card for dinner at Red Lobster. The School also issues "Golden Tickets" for a student who performs well. The tickets can be turned in for a prize from Ms. Copen.

The School held student achievement assessments. An Intervention Specialist started last week. The one-on-one aid has provided very positive results. The School is working on Ohio Department of Education assessments. The assessments will be completed by the September 20th.

The School will also have visits from a Speech Therapist and intervention psychologist.

The parents are embracing the School's culture. The School is using an interactive app, Classroom Dojo. The app allows for instant updates on a student and instant feedback from the parent. Parents also receive a weekly call from the School to notify them of events. The School will hold a Fall Festival for current and new families.

Ms. O'Bryan provided the Superintendent's Residency Verification Update. There are approximately 45 enrolled in the School. There are no flags or issues to report.
